

Charter governing reprints of texts from a Prescrire publication

In order to carry out its comparative, critical analyses to the fullest extent and in total freedom, Prescrire is financed exclusively by the sale of subscriptions, and refuses to accept even one euro of advertising revenue.

The dissemination of reprints of *Prescrire's* articles by third parties (companies, administrative bodies, etc.) is subject to specific conditions. The purpose of this document is to spell out these conditions.

Prescrire retains exclusive copyright over its texts, or any reprints thereof.

Prescrire is responsible for the production of any reprints, and for choosing any outside suppliers that might be required (printing, packaging).

Reprints are invoiced to the requesting party at the cost-price (including a copyright fee), with this particular condition printed, in these terms, on the first page of the reprint.

In accordance with Prescrire's aims and ethics, the party requesting a reprint must adhere to the following conditions:

- the requesting party's reasons must be respectable and must not be a part of any practice which constitutes unfair competition;
- the text must be reprinted in its entirety, and no changes must be made in the text or in its references;
- the source and the publication date of the text as well as the Prescrire logo must appear on the reprint.

Requests for permission to distribute reprints from Prescrire publications are submitted, in writing, to Prescrire's management, accompanied by information regarding the name and the job title of the requesting party; the references of the text; the number of copies requested, and the desired mode of delivery. Requests must also explain, as clearly as possible, the reasons for the request, and specify the context in which the reprints will be distributed (name and address of the organisation that will be using the reprints, how they are to be distributed, the dates, etc.).

The decision to approve the production and sale of a reprint of an article from a Prescrire publication is subject to the approval of Prescrire's management, based on the information required as specified above.

The request may be accepted as submitted by the requesting party. It may be rejected as submitted by the requesting party. The request may be rejected as submitted by the requesting party, but with a counterproposal by Prescrire.

Prescrire's management will make its answer known to the requesting party within a reasonable period of time, accompanied by a price quote if the answer is affirmative.
