

## THE FINANCES OF ASSOCIATION MIEUX PRESCRIRE

The 2007-2008 fiscal year of Association Mieux Prescrire, which ended on 31 August 2008 (a), was marked by the launch of our *Improving Professional Practices* series.

Subscriptions to *la revue Prescrire* were up slightly, with the number of paying subscribers surpassing the

30 000 mark during the fiscal year. Subscriptions to the "Prescrire Integral Package" also rose to 5 248. Subscribers to the "Prescrire Integral Package" receive a subscription to *la revue Prescrire* along with access to the *Prescrire* electronic library; the package can be paid for by monthly direct debit.

Our training programmes have shown particularly strong growth during the 2007-2008 fiscal year. There were record numbers of participants:

3 907 participants in our *Thematic Training Programme* and 3 571 participants in the *Prescribe Monthly Readers' Test*. We also offered *Improving Professional Practices* series: 461 subscribers enrolled for the *Ongoing Practice Improvement Programme* and 451 enrolled for the *Themes for Improving Practice Programme*.

Over 85% of subscribers to our French edition *la revue Prescrire* renewed their subscriptions, and over 95% renewed their subscriptions for the “*Prescrire* Integral Package”.

Renewal rates for our Continuing Education Programmes are also very high: over 80% of participants in *Prescrire's Monthly Readers' Test* and over 93% of participants in *Prescrire's Thematic Training Programme* enrolled again for the following year.

By renewing their subscriptions in such large numbers, the readers of *Prescrire* and the participants in our Continuing Education Programmes are giving themselves the means to work for continued, high-quality care.

They are also sending a clear signal that they share *Prescrire's* values of independence, reliability and transparency, and our commitment to a true interest in patient health and commitment to community issues.

From an accounting perspective, our income was in line with expectations while expenditures were lower than expected mainly as a result of a number of deferred investments.

Our cash balance is therefore higher at the end of this fiscal period. The current economic crisis may lead to harder times, so the security provided by this increase in our cash balance will help safeguard *Prescrire's* future. These funds will also help us to continue to work on many projects that are currently under development.

We plan to launch new Continuing Education Programmes in the years to come, in response to the specific needs of healthcare professionals. Furthermore, improvements to our IT systems, particularly our website [www.prescrire.org](http://www.prescrire.org), are scheduled; these improvements will give subscribers easier access to the resources we provide. Technical improvements to the *Bibliothèque électronique Prescrire* and *Prescrire's Monthly Readers' Test* are also being studied.

We plan to increase our circulation outside the French-speaking world, with an increased frequency of publications in English.

*Prescrire's* business model is based on maximum independence, in the interests of its subscribers only. Strict management of our finances, combined with continuing education programmes that are constantly being improved to meet the expectations and needs of our subscribers, is one of the prerequisites of the continued survival and success of *Prescrire*.


## AMP : fiscal year 2007-2008

Income (ex-tax) : €8 451 K


Expenditure (ex-tax) : €7 847 K
