2 plenary sessions

The opening session Friday morning presents an overview of the primary obstacles to access to quality care. The closing session Saturday morning explores "Decision-making in a situation of complexity".

10 workshops

 - for non-prescription drugs (to be recommended in pharmacies)

Workshops will be repeated 3 times, allowing each participant to attend 3 different workshops.
